This event is scheduled to be held on January 21, 2017 from 1:00 pm to 4:30 pm at 414 Lake St, 406 Lake St, 384 Lake St, 960 Main St, 959 Main St. Suite 2, 345 Park Ave Suite 5, 345 Park Ave Suite 3 & 4, 931 Main St., 911 Main St, 909 Main St, 893 Main St, 891 Main St, 896 Main St, 906 Main St, 928 Main St, 381 Lake St, 389 Lake St, 925 Toft Ave located in Antioch. At this time these locations are requested to participate in the wine walk, but from time to time one or two change due to schedule conflicts that come up.
